We are writing to remind you that the 2022 Special Meeting of Stockholders (the “Special Meeting”) of BlackRock Capital Investment Corporation (the “Company”) will be held on Tuesday, May 3, 2022.

Our records indicate that as of March 4, 2022, the “Record Date” for the Special Meeting, you held shares of the Company and, therefore, you are entitled to vote on the matter described in the Company’s Definitive Proxy Statement for the Special Meeting (the “Proxy Statement”) and set forth on the green proxy card attached thereto, which were mailed to you on or about March 16, 2022.
